1. Introduction

Filcoflex B.V. hereby declares that, based on the information and declarations provided by the supplier, the products referred to in chapter 2, hereinafter referred to as the "products", do not contain any of the food allergens sensitive substances listed in chapter 3, hereinafter referred to as the "substances."

These substances are not present as any intentionally added substances in the formulation of the raw material suppliers and therefore are not expected to be present. The substances are also not present as intentionally added substance in the formulation. Nor are they intentionally added during the manufacturing of the end products.
